#### LETTER TO VENDORS

The following is a list of the requirements that will be enforced for the 2024 shows with "NO EXCEPTIONS".

All accepted Vendors shall have all monies owed, paid in full before being allowed to set up their booth. "NO EXCEPTIONS"

PAYMENT MUST BE RECEIVED IN FULL BY 12/20/2023 SO PLEASE MAIL ACCORDINGLY. There will be no guarantee of a particular space, as the spaces will be filled on a paid-in-full basis starting 12/20/2023. This is necessary due to the preparations for the shows.

There will be NO refunds FOR VENDORS after closing date of Cluster I.

Times will be designated to restock your booth and will be enforced. If you have exceptionally large deliveries to the park, (Semi-Trucks) we suggest the deliveries be made later in the afternoon. If you have clients coming to pick up product, your clients WILL be expected to pay to enter the park. NO EXCEPTIONS.

Clients may only park behind your booth for loading and will have a maximum of 15 minutes.

If you work from a trailer and it is part of your booth, you MUST rent a space large enough to include the tongue of the trailer. Several vendors rent tents that are set up the week prior to the shows. Your space will NOT be reassigned once it is assigned. Be prepared and arrive early enough and have the correct means to set up your booth. While we will make every effort to accommodate all, your space could be between 2 of the preset tents. The tents CANNOT be moved and there might not be any other spaces available.

Vendors for the 1<sup>st</sup> cluster only must be cleaned up and out of the booth space, including personal tents, by 12:00 NOON on Tuesday, January 16. Vendors staying for both clusters must have the booth space cleared by 12:00 NOON on Monday January 22<sup>rd</sup>.
